- 2. Construction of alternative staircase shall be completed within 30 days from the received of this certificate.
- 3. Driveway must be free of any type of obstruction for easy movement of Fire Appliances. No parking will be allowed on the Drive way.

- 5. To eliminate risk of Fire Hazards, Good House Keeping both for insides and outside of the building shall be strictly maintained.
- 6. Electrical wiring of the all building shall have to be carefully checked for any were and tear in them, particularly lines above false ceiling & ducts. Electrical safety Audit to be conducted positively by 31st March every year. The notice of Fire Fighting and Evacuation from the building shall be prepared and displayed at all venerable of the
- 7. The employees and security staff shall be conversant with installed Fire Fighting equipment of the building and to operate in the event of Fire and Testing.
- 8. Mock Fire Practice and evacuation drill shall be performed periodically with participants of all the occupants of the building.
- 9. Arrangement shall have to be made for regular checking, testing and maintenance of all the Fire Fighting installation in the Building to keep them in perfectly good working condition at all the times.
- 10. Periodical flashing of water in the Hydrants, Pipe line shall be made to maintain the efficiency working performance of above mention system.
- 11. The Fire Safety audit to be conducted a regular interval and to be recorded in the Fire Prevention maintenance register.
- 12. This certificate valid for 03 years. A Renewal Certificate shall have to be obtained every three years from the date of issuance of this certificate from the Divisional Fire Officer South 24 Parganas Division, West Bengal Fire & Emergency Services for performance of all the life & Fire Safety arrangements and installations of the building.
